 - Make premium payment to Jubilee Insurance Company Kenya Limited and send the completed form together with copy of your National ID/Passport & KRA PIN.
 - You will in return receive a premium payment receipt, a medical professional indemnity certificate and your

policy document.

- **How do I make a claim?**

- Kindly inform Jubilee Insurance Company Kenya Ltd of any Act that might lead to a claim as soon as practical.
- The Act includes any notice received by you from a claimant of an alleged claim/complaint, demand letters, court summons
- Complete our Doctors Professional Indemnity Claim Form
- Attach all other documentation as may be requested
- Cooperate with us in all aspects of the claim
- Always seek our consent before entering into a compromise/settlement with any claimant.
